

TUITION RATES for Full Year Programs: Effective **March 1, 2022**

Starting 3/1/2022, only families receiving CCFAP (VT Child Care Subsidy) will be eligible for WEEKLY tuition. Please enquire about rates. **We do not accept credit card payments and require all families to enroll in Bank Direct Debit (ACH). All tuition is due in advance of month/quarter of attendance.**

- From 3/1/2022, we offer a 5% **discount off the monthly rates for quarterly payments.**
- Quarterly payments are due on March 1, June 1, September 1 and December 1.
- We offer an additional 10% sibling discount off the lowest tuition.
- **A one time, non-refundable registration fee of \$80 for all newly registered families.**
- **We also require a refundable deposit equal to ½ month for monthly and ½ Quarter for quarterly payors for new registered families or for families changing tuition payment schedule from monthly to quarterly.**

Birth to Three Program (6 weeks – Sept 1 after aged 3)

NOTE: Only Full Time enrollment is available in the Infant (age 0-1) program. Both Full Time and Part Time enrollment are available in the Mobile Infant/Toddler (age 1-3) Programs.

Full-time rates (Monday-Friday) - all age 0-3 programming

\$1540 per month paid monthly on 1st of month preceding month of care

\$4390 per quarter payable Mar 1, June 1, Sep 1, Dec 1. – 5% discount over MONTHLY rates. **(\$920 savings per year – quarterly tuition represents a \$337.69/weekly equivalent)**

Part-time rates (minimum 2 days/week) - for Mobile Infant/Toddler (age 1-3) Programs ONLY

\$740 per Month for enrolling 2 days/week

\$1110 per Month for enrolling 3 days/week

\$2105 per Quarter for enrolling 2 days/week – 5% discount over MONTHLY rates. **(\$460 savings per year)**

\$3160 per Quarter for enrolling 3 days/week – 5% discount over MONTHLY rates. **(\$680 savings per year)**

NOTE: Birth to Three rates will apply for children thru August 31 of the year preceding Preschool i.e. until the family qualifies for Act 166 funding as of September 1 after the child is 3 years old.

Preschool Program (3 to 5 years) – Full Day Program

NOTE: Act 166 (Public PreK) funding of \$3656 for 2022/23 will cover 10 hours per week for all preschoolers who will be age 3 on or before September 1, 2022. This will automatically be applied during the school district year i.e. Monthly – 10 months, Quarterly – 3 Quarters. For the remaining period (approx. June 15-Aug 31) an equal discount will be applied to provide a FLAT RATE billing structure and enable families to budget through the calendar year.

Monthly Payors! – a 12-month flat rate

\$1130 per month co-payment AFTER credit for 2022/23 Act 166 funding of \$3656 or \$365.60/month has been applied. **If not eligible for Act 166, the full tuition rate of \$1495.60/month will be applied.**

Quarterly Payors! – a 4-quarter flat rate

\$3220 per quarter co-payment AFTER credit for 2022/23 Act 166 funding of \$3656 or \$1218.67/quarter has been applied.

Includes a 5% discount off monthly rates, **(\$680 savings per year! and represents a \$247.69/weekly equivalent).** **If not eligible for Act 166 the full tuition rate of \$4438.67/quarter will be applied.**

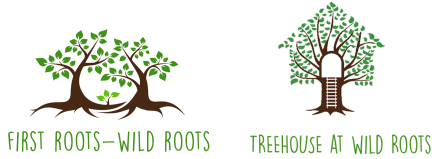
Part-time Preschool Option! - This is a FULL DAY option -- 4 days are billed as full week as set out above above.

\$580 per Month for enrolling 2 days/week

\$865 per Month for enrolling 3 days/week

\$1650 per Quarter for enrolling 2 days/week – after 5% discount over monthly rates. **(\$400 savings per year)**

\$2465 per Quarter for enrolling 3 days/week – after 5% discount over monthly rates. **(\$540 savings per year)**



TUITION RATES for Part Year Programs: Effective March 1, 2022

School Age Program (Ages 5 - 8) – School Year 2021/22 (limited to 20 participants!)

All Day HCS vacation/HCS in-service days (from Sept 1, 2021)

Winter and Spring Breaks

\$250/ 5 days

Other HCS Vacation and Inservice Days

\$ 50/ day

After School (2:30 dismissal from HCS: M, W, Th, Fr and early dismissal on W)

Daily

\$ 20/ day(min. 2 days)

Weekly

\$ 100/week

Monthly (charged at 4 x weekly rate)

\$ 400/month (M-F); \$80/ day.mo

Quarterly (5% off monthly)

\$ 1080/quarter, \$216/day quarter

The School Age Monthly rates are calculated at 4 x the weekly rates. This provides approximately a 7.5% discount. Vacation camps are separately charged with a credit for any vacation weeks previously paid.

Note: Summer Camp rates for the Summer 2022 season will be published by January 31, 2022 and registration will begin on or before 2/15/2022.

Preschool Program (3 to 5 years) – AM Part Day Program

We require a one-time **returnable** deposit of \$280 and a **non-returnable** registration fee of \$80 upon registration for our Part Day program of 10 ¼ hours per week.

Minimum enrollment of 3-half days.(minimum of 10.25 hours/week) - **No “out of pocket” tuition charge to Families!**

NOTE: **Act 166 credits of \$3656 will cover the Tuition for 10 hours/wk of our 35-week program** for children who will be age 3 on or before September 1, 2022. This program follows the CVSD (Champlain Valley School District) school calendar.

Additional days will be charged as follows:

For enrolling **4 half days/week** -- **\$150/month** for 10 months -- **same as school year 2021/22**

For enrolling **5 half days/week** -- **\$240/month** for 10 months -- **same as school year 2021/22**

For those families that enter the program during the year but **do not** qualify for Act 166 funding, the tuition will be **\$490/month** for enrolling **3 half days/week**.
