



TUITION RATES for Full Year Programs: Effective March 1, 2023 (revised April 2023)

We do not accept credit card payments and require all families to enroll in Bank Direct Debit (ACH). All tuition is due in advance of month/quarter of attendance.

- We offer a 5% discount for quarterly payments.
- Quarterly payments are due on March 1, June 1, September 1 and December 1.
- We offer a 10% sibling discount off the lowest tuition only.
- We have a one time, non-refundable, registration fee of \$80 for all newly registered families.
- We require a refundable deposit equal to ½ month for monthly tuition payments and ½ Quarter for quarterly tuition payments for new registered families, or for families changing tuition payment schedule from monthly to quarterly.

Infant & Toddler Program (6 weeks – to Sept 1 after 3rd Birthday)

NOTE: Only Full Time enrollment is available in the Infant-Toddler program (age 0-3).

\$1695 per Month paid monthly on 1st of month preceding month of care

\$4830 per Quarter payable Mar 1, June 1, Sep 1, Dec 1. – 5% discount over MONTHLY rates. (\$1020 savings per year quarterly tuition represents a \$371.54/weekly equivalent)

NOTE: Birth to Three rates will apply until the child qualifies for Act 166 funding, the September 1st after the child turns 3 years old irrespective of enrollment in a 3-5 year room

Preschool Program (3 to 5 years) – Full Day Program

Act 166 (Public PreK) funding of \$3764 for 2023/24 will cover 10 hours per week for all preschoolers who will be aged 3, 4 or 5 on or before September 1, 2023. This will automatically be applied during the school district year i.e. Monthly – 10 months, Quarterly – 3 Quarters. For the remaining period (approx. June 15-Aug 31) an equal discount will be applied to provide a **FLAT RATE** billing structure and enable families to budget through the calendar year.

\$1235 per Month co-payment AFTER credit for 2023/24 Act 166 funding of \$3764 or \$376.40/month (**over 10 months**) has been applied. **If not eligible for Act 166, the full tuition rate of \$1611.40/month will be applied.**

\$3520 per Quarter co-payment AFTER credit for 2022/23 Act 166 funding of \$3764 or \$1254.67/quarter (**over 3 quarters**) has been applied. Includes a 5% discount off monthly rates, (\$720 savings per year and represents a \$270.77/weekly equivalent). **If not eligible for Act 166 the full tuition rate of \$4774.67/quarter will be applied.**

Part-week Preschool Option! - This is a FULL DAY option -- 4 days are billed as full week as set out above.

2 Days option:

\$640 per Month for enrolling 2 days/week, if not eligible for Act166, full tuition of \$1016.40 will be applied.

\$1815 per Quarter for enrolling 2 days/week – after 5% discount over monthly rates.(\$420 savings per year over monthly), if not eligible for Act 166, full tuition of \$3069.67 will be applied.

3 Days option:

\$950 per Month for enrolling 3 days/week, if not eligible for Act166, full tuition of \$1326.40 will be applied.

\$2710 per Quarter for enrolling 3 days/week – after 5% discount over monthly rates.(\$560 savings per year over monthly), if not eligible for Act 166, full tuition of \$3964.67 will be applied.



TUITION RATES for Part Year Programs: Effective March 1, 2023 (revised April 2023)

Preschool Program (3 to 5 years) – Morning Part Day Program

We require a one-time **returnable** deposit of \$280 and a **non-returnable** registration fee of \$80 upon registration for our Part Day program of 10 ¼ hours per week.

Minimum enrollment of 3-half days.(minimum of 10.25 hours/week) - **No “out of pocket” tuition charge to Families!**

NOTE: Act 166 credits of \$3764 will cover the Tuition for 10 hours/wk of our 35-week program for children who will be age 3 on or before September 1, 2022. This program follows the CVSD (Champlain Valley School District) school calendar.

Additional days will be charged as follows:

- For enrolling **4 half days/week** -- **\$165/month** for 10 months -- Sept 1 thru June 1
- For enrolling **5 half days/week** -- **\$264/month** for 10 months -- Sept 1 Thru June 1

For those families that enter the program during the year but **do not** qualify for Act 166 funding, the tuition will be **\$540/month** for enrolling **3 half days/week**.

School Age Program (Ages 5 - 8) – School Year 2023/24 (limited to 20 participants!)

All Day HCS vacation/HCS in-service days (from Sept 1, 2023)

Winter and Spring Breaks

\$250/ 5 days

Other HCS Vacation and Inservice Days

\$ 50/ day

After School (2:30 dismissal from HCS: M, W, Th, Fr and early dismissal on W)

Daily

\$ 22/ day(min. 2 days)

Weekly

\$ 110/week

Monthly (charged at 4 x weekly rate)

\$ 440/month (M-F); \$80/ day.mo

Quarterly (5% off monthly)

\$ 1188/quarter, \$237.60/day.qtr

The School Age Monthly rates are calculated at 4 x the weekly rates. This provides approximately a 7.5% discount. Vacation camps are separately charged with a credit for any vacation weeks previously paid.

Note: Summer Camp rates for the Summer 2023 season will be published by January 31, 2023 and registration will begin on or before 2/15/2023.
